RESOLUTION NO. 01-29-97-E

Isaac and June Cornelius Lease Modification

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Isaac J. Cornelius and June M. Cornelius, both tribal members are holder of said lease no. RL-2559(94) more particularly described as follows:

A parcel of land located within Claim 21, and being a part of the N1/2SW 1/4, Section 30, Township 23 North, Range 19 East, 4th P.M., Outagamie County, Wisconsin, more particularly described as follows:

Commencing at the point where Claim 21 intersects with the centerline of Johnson Road; thence northwesterly following the north line of Claim 21, a distance of 730 feet to the Point of Beginning; thence left to the perpendicular 45 degrees in a southwesterly direction, a distance of 435 feet; thence right to the perpendicular 45 degrees in a northwesterly direction, a distance of 200 feet; thence right to the perpendicular 45 degrees northeasterly direction, a distance of 435 feet, more or less, to the north line of said Claim 21; thence right to the perpendicular 45 degrees in a southeasterly direction, a distance of 200 feet, more or less, to the Point of Beginning, containing 2.0 acres, more or less, subject to all valid existing rights-of-way of record.

WHEREAS, Isaac and June Cornelius, holders of said lease site wish to modify their lease as follows:

DELETE: Isaac J. Cornelius (deceased) and June M. Cornelius, both tribal members.


INSERT: June M. Cornelius #0908 and Lynne M. Cornelius #0948, both tribal members

NOW, THEREFORE, BE IT RESOLVED, by this Committee in regular session assembled, hereby approve the above modification of lease, and

BE IT FURTHER RESOLVED, that the Chairwoman and Secretary of the Oneida Business Committee are hereby authorized to execute lease **MODIFICATION** documents for and on behalf of the Oneida Tribe of Indians of Wisconsin.
