## **RESOLUTION # 05-12-99B**

Wisconsin Focus on Energy and WI. Dept. Of Administration Energy Bureau Grant

WHEREAS the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Environmental Resources Board (ERB) was created for the purpose of overseeing matters concerning the environment of the Oneida Reservation, and

WHEREAS, the Oneida Tribe is committed to living in balance with Mother Earth and protecting her health through the Seventh Generation, and

TEREAS, the Oneida Tribe has made the environment a National Priority. Facing an escalating global environmental crisis, the Oneida Community has become acutely aware of the limits and depletion of nonrenewable natural resources. We also understand that some of Wisconsin Public Service's power is created by local nuclear energy plants, and

WHEREAS, the Oneida Tribe understands that the benefits of renewable energy include a reduction of the pollution from burning fossil fuels such that one solar water heater used with an electric hot water heater will save one tone of coal per year. Reducing the amount of coal needed to produce electricity reduces the emissions of the gases responsible for global climate change, acid rain, and smog, and

WHEREAS, the Oneida Tribe understands that renewable energy systems provide a method for Native societies to move towards greater self-sufficiency while meeting the needs of contemporary life. It also demonstrates our ability to sustain an ecologically healthy environment for the future generations.

THEREFORE, BE IT RESOLVED, that the Oneida Tribe of Indians of Wisconsin submits a Wisconsin Focus on Energy grant application to the Wisconsin Department of Administration's Energy Bureau for the purpose of installing photovoltaic systems and solar hot water systems in home located within the Queida Reservation.
