Resolution # 05-14-97G

Adoption of Chapter 10, Oneida Code

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Administrative Procedures Act was the first step in that process begun in 1991 and continued until today in standardizing processes regarding laws and regulations of the Oneida Tribe, and

WHEREAS, the Legislative Operating Committee has developed the attached Chapter 10 of the Oneida Code which integrates and expands on the legislative processes in the Administrative Procedures Act, and

WHEREAS, Chapter 10 has been forwarded for Public Hearings on at least two occasions and received numerous reviews from the Oneida Business Committee, management of the Oneida Tribe, and the Oneida Law Office and is ready for adoption and implementation, and

NOW THEREFORE BE IT RESOLVED, that the attached Chapter 10 shall be adopted by this resolution and implemented within 30 days of adoption, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the Administrative Procedures Act, adopted by the Oneida Business Committee and ratified by the General Tribal Council by resolution GTC-8-19-91-A, and which has amendments ratified by the General Tribal Council on 1995, is hereby repealed as to Articles IV through IX, and those portions not specifically listed but which conflict with this Chapter 10, and

NOW THEREFORE BE IT FURTHER RESOLVED, that prior ordinances and policies which address formatting laws and policies, and drafting Statements of Effect are hereby repealed, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the Oneida Print Shop is hereby delegated the official printer of the Oneida Code and Administrative Code as forwarded by the Oneida Business Committee and shall be responsible for making available for the public this Code and Administrative Code and shall be granted the ability to charge fees to cover costs involved in printing these documents, and

NOW THEREFORE BE IT FINALLY RESOLVED, that the Oneida Business Committee directs that the following chapters of the Oneida Code shall be reserved for adoption and amendment by the General Tribal Council, and authorizing the Oneida Business Committee to adopt and amend all other chapters as needed to integrate existing laws of the Oneida Tribe —

Chapter 10 - Code


Chapter 11 - Civil Proceedings

Chapter 12 - Gaming.
