### **RESOLUTION # BC-8-31-94-B**

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, there is a Conflict of Interest Law tabled on the General Tribal Council Agenda and the Legislative Operating Committee is currently working on an Ethics Law and Conflict of Interest Law, and


WHEREAS, there is a need for a policy statement and position to be taken by the Oneida Nation regarding gifts given to members of Boards, Committees and Commissions, including the Oneida Business Committee,

NOW THEREFORE BE IT RESOLVED: that the attached form shall be filed by all members of the Oneida Business Committee, and all members of all boards, committees and commissions within thirty (30) calendar days of receipt of any gift, of value greater than \$50.00, in the Oneida Tribal Secretary's office to be placed on the agenda and proper recognition given to the donor and recipient, and

NOW THEREFORE BE IT FINALLY RESOLVED: that the Oneida Business Committee hereby adopts this interim policy until such a time as permanent Conflicts and Ethics laws can be adopted, and said policy shall become effective within ten (10) business days of adoption.

CERTIFICATION
