Resolution # BC- 11-9-98-A

Resolution for the Emergency Amendment of the Oneida Recycling and Solid Waste Disposal Law

- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the General Tribal Council has been delegated the authority of Article IV, Section I. of the Oneida Tribal Constitution, and
- WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS, the Oneida Business Committee passed Resolution #09-02-98-A, amending the Oneida Tribal Sanitary District Ordinance to include the safe collection of solid waste refuse and recyclable material and for the Oneida Utilities Commission to charge and/or seek grants for the same,
- WHEREAS, the Oneida Recycling and Solid Waste Disposal Law makes no mention of the Oneida Utilities Commission, and
- WHEREAS, the Oneida Business Committee finds an immediate need to amend the Oneida Recycling and Solid Waste Disposal Law, because it is necessary for the preservation of public health, safety, and welfare of the reservation, to include the Oneida Utilities Commission in the Oneida Recycling and Solid Waste Disposal Law, and
- WHEREAS, the Oneida Tribe currently offers solid waste and recycling collection through contracts for those businesses and families within the reservation not receiving this service from local government, and
- WHEREAS, this duplication of efforts of the Oneida Tribe and local governments has resulted in multiple solid waste and recycling contracts for the same area

which has resulted in two or more solid waste and/or recycling vehicles on the same road which were contracted for by different governments, and

WHEREAS, the local governments have entered into negotiations, of which the Oneida Tribe participated, to avoid this overlapping service and to allow the governments to use those funds for alternative purposes, and

WHEREAS, the time frame for entering into these cooperative or combined agreements for a single service coverage is governed in part by the current contracts coming to an end, and

WHEREAS, the Oneida Business Committee finds that an amendment to the Oneida Recycling and Solid Waste Disposal Law is in the best interest of the public.


NOW THEREFORE BE IT RESOLVED, that the Oneida Recycling and Solid Waste Disposal Law is amended as follows:

An Article XIII., at the end of the last sentence, add the following which states: The Oneida Business Committee further delegates to the Oneida Utilities Commission the authority to set and collect rates and fees, in a reasonable and equitable manner, and to enter into agreements for the collection of recyclable materials and solid waste.

BE IN FINALLY RESOLVED, that said emergency amendments be in force and effect from the date of this resolution and will expire in six months thereof, unless time is extended by the Oneida Business Committee, or a permanent amendment replaces the emergency amendment.
