## RESOLUTION # 11-20-96-B

WHEREAS the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: OLC, 2640 WEST POINT ROAD, GREEN BAY, WI.

WHEREAS the parcel is described as follows:  
Part of the Northeast quarter if the Southwest quarter, part of Lots 25, 26, 27, and 28 of the Southeast quarter of the Southwest quarter, and part of Lot 20 of the Northwest quarter of the Southwest quarter, all located in Section 29, Township 24 North, Range 20 East, City of Green Bay, Brown County, Wisconsin described by:  
Commencing at the southeasterly corner of the said Southeast quarter of the Southwest quarter; thence South 89 degrees 42 minutes 45 seconds West along the southerly line of the said Southeast quarter of the Southwest quarter 450.04 feet; thence North 0 degrees 25 minutes 59 seconds East 35.00 feet to a point on the northerly right-of-way line of West Point Road, said point being the point of beginning; thence South 89 degrees 42 minutes 45 seconds West along the said northerly right-of-way line 270.02 feet to the westerly line of the property described in Volume 593 Page 21 Brown County Records; thence North 0 degrees 25 minutes 59 seconds East along the said westerly line 196.73 feet; thence South 89 degrees 44 minutes 10 seconds West along the northerly line of property described in Volume 5 Certified Survey Maps Page 289 Brown County Records and the extension thereof and along the northerly line of the property described in Volume 5 Certified Survey Maps Page 283 Brown County Records 600.84 feet to the westerly line of the said Southeast quarter of the Southwest quarter; thence North 0 degrees 10 minutes 34 seconds East along the said westerly line 1084.15 feet to the southerly line of the said Northwest quarter of the Southwest quarter; thence South 89 degrees 43 minutes 49 seconds West along the said southerly line 66.02 feet to the westerly line of said Lot 20 of the Northwest quarter of the Southwest quarter; thence North 0 degrees 14 minutes 42 seconds East along the said westerly line

Telephone Company (now Ameritech) recorded in Volume 4 Miscellaneous Records Page 469 Brown County Records. **AND EXCEPTING THEREFROM** that part of Government Lots 27 and 28, Section 29, Township 24 North, Range 20 East, City of Green Bay, Brown County, Wisconsin, described as follows: Commencing at the south  $\frac{1}{4}$  corner of said section 29; thence N. 90°-00'00"W, 720.00 feet along the south line of said Section 29 to a point on the southerly extension of the east line of Lot 4 of the Certified Survey Map recorded in Volume 5, Page 289, Brown County Records (being part of said Government Lots 27 and 28); thence N. 00°-43'-00"E, 35.00 feet to the southeast corner of said Lot 4; thence continuing N. 00°43'-00"E., 326.78 feet along the east line of Lot 4 and the northerly extension thereof to a point on the north line of said Government Lot 27; thence S. 89°-58'-30"E., 180.00 feet along said north line of Government Lot 27; thence S. 00°-43'-00"W., 326.70 feet to a point on the north line of West Point Road; thence N. 90°-00'00"W., 180.00 feet along said north line of West Point Road to the point of beginning, containing 58,809 square feet/1.35 acres more or less.



WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
