- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as:
Former Margaret D. Vannieuwenhoven Property
- WHEREAS, the parcel is described as follows:
Legal Description: See attached.
Tax Parcel Numbers: HB-1342-3, HB-1357, HB-1358, HB-1359, HB-1361 and HB-1362
- WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provide a vacant land and will not be used for gaming purposes, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement,

NOW THEREFORE, BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.

All of Indian Claims One Hundred Sixty-six (166) and One Hundred Sixty-seven (167), part of Indian Claims One Hundred Sixty-five (165), One Hundred Sixty-eight (168), One Hundred Sixty-nine (169) and One Hundred Fifty-five (155), in Section Thirty-four (34), Township Twenty-four (24) North, Range Nineteen (19) East of the Fourth Principal Meridian, and part of Indian Claim One Hundred Fifty-five (155), in Section Three (3), Township Twenty-three (23) North, Range Nineteen (19) East of the Fourth Principal Meridian, all in the Town of Hobart, Brown County, Wisconsin, more full described as follows:

Commencing at the Northeast corner of Indian Claim 165; thence N 57° 32' 43" W, 39.44 feet along the Northerly line of Indian Claim 165 to the Westerly right-of-way of West Mason Street, and the point of beginning; thence S 34° 03' 08" W, 2349.07 feet along said right-of-way; thence 629.74 feet along said right-of-way being the arc of a 2814.76 foot radius curve to the right whose long chord bears S 40° 27' 41" W, 628.43 feet; thence S 46° 52' 15" W, 22.08 feet along said right-of-way; thence N 59° 01' 11" W, 614.78 feet along the Northerly line of Jacket 9260, Image 11, Brown County Records; thence S 30° 30' 29" W, 108.00 feet along the Westerly line of Jacket 9260, Image 11 and Jacket 6248, Image 6, Brown County Records; thence N 59° 01' 11" W, 546.38 feet along the Southerly line of Indian Claim 155 to a point that is S 59° 01' 11" E, 34 feet, more or less, from the waters of Duck Creek and is the start of a meander line; thence N 0° 00' 00" E, 300.00 feet along said meander line; thence N 23° 32' 57" W, 564.01 feet along said meander line; thence N 57° 05' 41" E, 404.97 feet along said meander line; thence S 59° 44' 37" E, 277.85 feet along said meander line; thence N 85° 14' 11" E, 240.83 feet along said meander line; thence N 33° 41' 24" E, 360.56 feet along said meander line; thence N 16° 23' 22" W, 708.80 feet along said meander line; thence N 33° 52' 12" E, 1210.16 feet along said meander line to the point which is S 57° 32' 43" E, 8 feet, more or less from the waters of Duck Creek and is the end of said meander line; thence S 57° 32' 43" E, 1801.97 feet along the Northerly line of Indian Claims 167, 166 and 165 to the point of beginning. Including all lands lying between the meander line and the waters of Duck Creek.
